TERMS AND CONDITIONS

Definitions:

Immediate Family: means spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

Promoter: means TEEG Australia Pty Ltd (ABN 61 003 710 110) of Level 8, 60 Miller Street, North Sydney, 2060 NSW, trading as Timezone.

Promotion: means the "Zone Bowling Bike Giveaway" governed by these terms and conditions.

Promotional Period: means the period commencing on 17/09/2025 at 09:00 AEST and ending on 13/10/2025 at 23:59 AEDT

Qualifying Transaction: entrants must make an instore purchase of a Gordon's Pink Gin Bucket at a participating Zone Bowling venue in Australia during the Promotional Period

Terms and Conditions:

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry into this Promotion is only open to Australian residents, 18 years and older.
- 3. Employees of the Promoter and their Immediate Families and any agencies associated with this Promotion are ineligible to enter the Promotion. Any entry by an employee of the Promoter or their Immediate Family will be treated as an invalid entry resulting in the forfeiture of any right to win a prize.
